Eye Contact

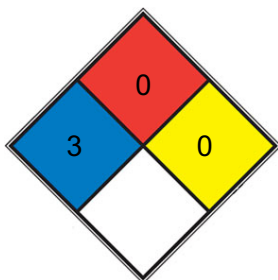
