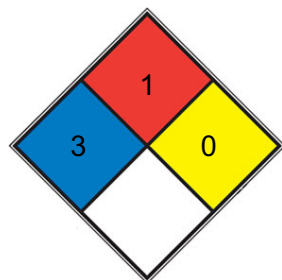

Skin protection
