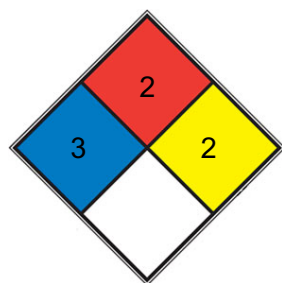
**Advice for firefighters**
