General Advice

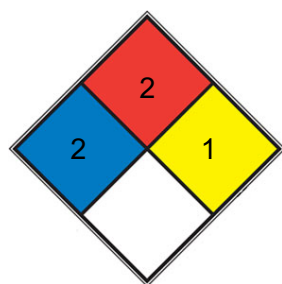
