**Persistence and degradability**

7-Methylbenz(a)anthracene was oxidized by the fungus *Cunninghamella elegans* to trans-8,9-dihydroxy-8,9-dihydro-7-hydroxymethylbenz(a)anthracene and trans-3,4-dihydroxy-3,4-dihydro-7-hydroxymethylbenz(a)anthracene(1).

**Bioaccumulative potential**

An estimated BCF of  $7.9 \times 10^3$  was calculated for 7-methylbenz(a)anthracene(SRC), using a measured water solubility of 0.011 mg/l(1) and a recommended regression-derived equation(2). According to a classification scheme(3), this BCF suggests that bioconcentration in aquatic organisms is very high(SRC).

## Mobility in soil

The Koc of 7-methylbenz(a)anthracene is estimated as approximately  $5.2 \times 10^4$  (SRC), using a measured water solubility of 0.011 mg/l(1) and a regression-derived equation(2,SRC). According to a recommended classification scheme(3), this estimated Koc value suggests that 7-methylbenz(a)anthracene is expected to be immobile soil(SRC).

## Disposal methods

### Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

### Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
