Eye contact

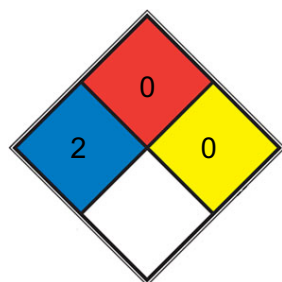
