Eye contact

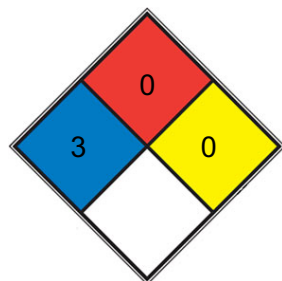
