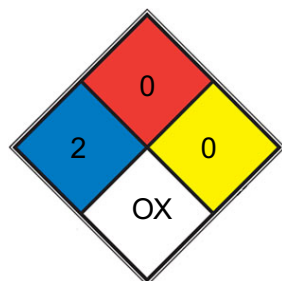
Oxidizer
