Precautions for safe handling

Store in cool place. Keep container tightly closed in a dry and well-ventilated place. Containers which are opened must be carefully resealed and kept upright to prevent leakage. Recommended storage temperature -20 °C Store under nitrogen.

Skin protection

Dispose of contaminated gloves after use in accordance with applicable laws and good laboratory practices. Wash and dry hands.
