#### Eye contact

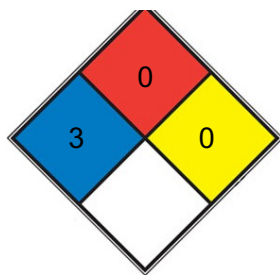
