Eye contact

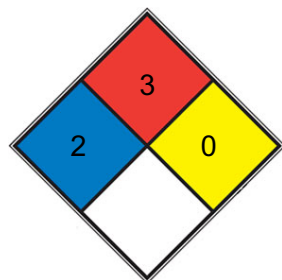
