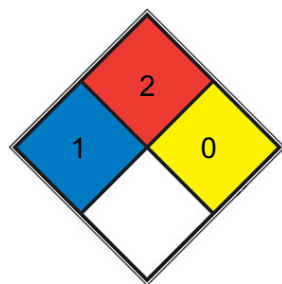

## SECTION 6: Accidental release measures

### Personal precautions, protective equipment and emergency procedures

Remove all ignition sources. Personal protection: filter respirator for organic gases and vapours adapted to the airborne concentration of the substance. Collect leaking liquid in sealable containers. Absorb remaining liquid in sand or inert absorbent. Then store and dispose of according to local regulations.

### Environmental precautions

Prevent further spillage or leakage if it is safe to do so. Do not let the chemical enter drains. Discharge into the environment must be avoided.

### **Methods and materials for containment and cleaning up**

Collect and arrange disposal. Keep the chemical in suitable and closed containers for disposal. Remove all sources of ignition. Use spark-proof tools and explosion-proof equipment. Adhered or collected material should be promptly disposed of, in accordance with appropriate laws and regulations.

NO open flames, NO sparks and NO smoking. Above 21°C use a closed system, ventilation and explosion-proof electrical equipment. Handling in a well ventilated place. Wear suitable protective clothing. Avoid contact with skin and eyes. Avoid formation of dust and aerosols. Use non-sparking tools. Prevent fire caused by electrostatic discharge steam.

#### **Product**

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

#### **Contaminated packaging**

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.

## Other Information

This is a mixture of saturated aliphatic and alicyclic hydrocarbons (C7-C12) and aromatic hydrocarbons (C7-C12). May contain benzene (see ICSC 0015) but modern Stoddard solvents usually contain little or no benzene. The symptoms of chemical pneumonitis often do not become manifest until a few hours have passed and they are aggravated by physical effort. Rest and medical observation are therefore essential. Auto-ignition temperature may be reduced to approx. 180°C in the presence of a high-surface-area material. Flash points may vary from 21 to 60 °C depending on the composition.
