SECTION 4: First aid measures

Description of first aid measures

If inhaled

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately.

Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

Following skin contact

Take off contaminated clothing immediately. Wash off with soap and plenty of water. Consult a doctor.

Following eye contact

Rinse with pure water for at least 15 minutes. Consult a doctor.

Following ingestion

Rinse mouth with water. Do not induce vomiting. Never give anything by mouth to an unconscious person. Call a doctor or Poison Control Center immediately.

Most important symptoms and effects, both acute and delayed

Excessive inhalation of dust may cause irritation of lungs and delayed symptoms similar to those observed after ingestion. Dust irritates eyes and skin and may be absorbed through skin on prolonged exposure. Ingestion causes irritation of mouth and stomach; inflammation of kidney and liver develops 1 to 4 days after exposure. (USCG, 1999)

Indication of any immediate medical attention and special treatment needed

Basic treatment: Establish a patent airway. Suction if necessary. Watch for signs of respiratory insufficiency and assist ventilations if necessary. Administer oxygen by nonrebreather mask at 10 to 15 L/min. Monitor for shock and treat if necessary ... Anticipate seizures and treat if necessary ... Perform routine emergency care for associated injuries. For eye contamination, flush eyes immediately with water. Irrigate each eye continuously during transport ... Do not use emetics. For ingestion, rinse mouth and administer 5 ml/kg up to 200 ml of water for dilution if the patient can swallow, has a good gag reflex, and does not drool ... Perform routine BLS care as necessary. Radioactives I, II, and III

Use dry chemical, carbon dioxide or alcohol-resistant foam.

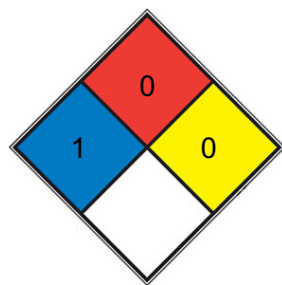
Specific Hazards Arising from the Chemical

Special Hazards of Combustion Products: Toxic oxides of nitrogen formed in fires. Behavior in Fire: Intensifies fires. When large quantities are involved, nitrate may fuse or melt; application of water may then cause extensive scattering of molten material. (USCG, 1999)

Advice for firefighters

Wear self-contained breathing apparatus for firefighting if necessary.

SECTION 6: Accidental release measures

Personal precautions, protective equipment and emergency procedures

Avoid dust formation. Avoid breathing mist, gas or vapours. Avoid contacting with skin and eye. Use personal protective equipment. Wear chemical impermeable gloves. Ensure adequate ventilation. Remove all sources of ignition. Evacuate personnel to safe areas. Keep people away from and upwind of spill/leak.

Environmental precautions

Prevent further spillage or leakage if it is safe to do so. Do not let the chemical enter drains. Discharge into the environment must be avoided.

Methods and materials for containment and cleaning up

Collect and arrange disposal. Keep the chemical in suitable and closed containers for disposal. Remove all sources of ignition. Use spark-proof tools and explosion-proof equipment. Adhered or collected material should be promptly disposed of, in accordance with appropriate laws and regulations.

SECTION 7: Handling and storage

Precautions for safe handling

Handling in a well ventilated place. Wear suitable protective clothing. Avoid contact with skin and eyes. Avoid formation of dust and aerosols. Use non-sparking tools. Prevent fire caused by electrostatic discharge steam.

Conditions for safe storage, including any incompatibilities

Store the container tightly closed in a dry, cool and well-ventilated place. Store apart from foodstuff containers or incompatible materials.

Not flammable ... /Uranium nitrate hexahydrate/Mixtures of metal/nonmetal nitrates with alkyl esters may explode, owing to the formation of alkyl nitrates; mixtures of the nitrate with phosphorus, tin (II) chloride, or other reducing agents may react explosively [Bretherick 1979. p. 108-109]. Diethyl ether and uranyl nitrate have been involved in several explosion and fire incidents [Nucl. Sci. Abs., 1976, 33], 19790 [J. Amer. Chem. Soc., 1912, 34, 1686].
